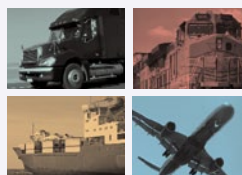

John Gross – Honorary member, past president and retired General Traffic Manager for Inland Steel Company, passed away on January 30 following a stroke suffered a few months ago. He was 90. Mr. Gross was a long time member of the Club, 58 years, joining in June, 1954 as the Assistant General Traffic Manager for Inland. During his many years as a member, he was very active in the club and served on many committees including, House, Education, Trustees & Finance, Public Affairs and Annual Dinner.
