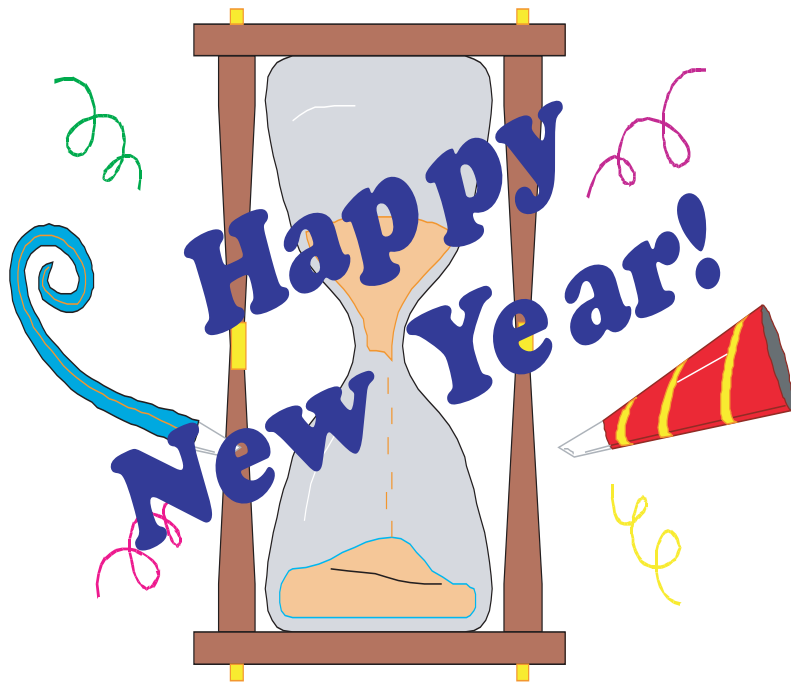

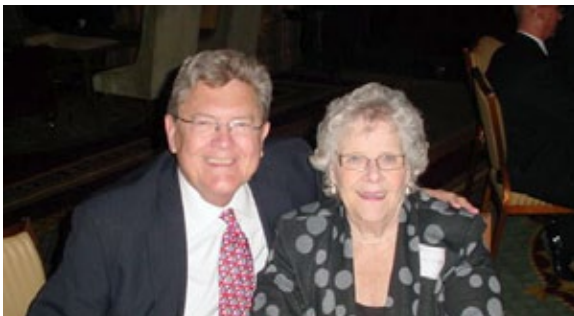

Art Leitherer – Honorary member, past president and retired Vice President of Traffic for Allied Mills passed away on February 24, 2010 at the age of 96. Mr. Leitherer was a long time member of the club, joining in 1952 when he was then Assistant General Traffic Manager for the company. He was a very active member of the club during his entire career and besides serving as the club's 61st president in 1968-69, served on and chaired numerous committees including Annual Dinner, Bowling Education, Fine Arts, House, Indoor Entertainment, Public Affairs and Sports & Pastimes. Mr. Leitherer was also honored by being elected to serve as President of the National Industrial Traffic League in the early 70's. One of the highlights of his career came when he was invited by President Ford to attend a reception at the White House following the signing of the Staggers Rail Act. Upon his retirement in 1979 he was awarded honorary membership and resided at his home in West Chicago until his passing.
