### Big Year for North American Freight Railroading

2018 is a crucial test for the future direction of freight railroads (and the start of the year doesn't give confidence). Rails ended 2017 with a good quarter (much, much better than what we expected a year ago at this time). Financially, things were super – record-low OR's, solid (above-WACC) ROIC, solid 2-3% pricing increases and good productivity combined to mean that most carriers beat expectations for the quarter (and for all four quarters, progressively). It was a year of high drama – (two) hurricanes plus Hurricane Hunter (and his untimely passing).

But, will we look back at 2017 as the beginning of a period of lost opportunity? There was little regulatory pressure last year (not to say Washington was an oasis of quietness). The modal competitive situation is tilting in the rails' direction, and the economy is growing. Will the rails whiff on the tipped fastball down the middle? That is hardly written in stone, but some worrisome signs have emerged:

 Rail service became an issue again – with an STB "Listening Session" on CSX but also issues emerging by year end at virtually every carrier (notably CN and NS). The "service metrics" showed mild deterioration every week by every carrier (with few short-lived exceptions): Dwell and cars-online increased by ~5% and ~2%, respectively, while velocity slipped 4%. Not a "meltdown" for sure, despite such terms being bandied about at times, but not great either, even with weather disruptions.

- Service issues may cause rails to miss one of the best market share opportunities in years. Trucking capacity issues exacerbated by federal regulations (ELDs) and declining infrastructure (without relief in sight, mind you) have given rails the opportunity to gain or regain share in some carload segments (paper, lumber, auto parts, etc.) and, especially, intermodal. True, intermodal volumes were up 5.8% for the quarter (and almost 5% for FY17) – but that was led by almost 8% growth in international containers – and domestic, truck-competitive boxes grew only 2.5%
- Trade issues remain unresolved heading towards election season in the US and, importantly, Mexico....
- Technology no longer appears as a friend to the rails, on the surface, as consistent attention paid to AV trucking reminds us that "winter is coming"
- Investors remain focused on shorter term issues such as (the cult of) OR improvement, using the strong cash flow generation enhanced by the tax cut toward direct shareholder action such as buybacks over growth (but not maintenance) capex....

But, as I said, the future isn't written yet. For those five elements of concern, there are an equal number of portents showing that the future of the "railroad renaissance" is still bright, and that the ol' railways can still turn on a fastball:

- Rail service was finally the area of investor and management focus by year end; CSX has at least "stabilized; CN has a well-financed plan of attack (and frankly they grew much faster – ~10% - than expected)
- 2. Railroads and Amazon can be friends! domestic container growth will be an area of intense scrutiny but the 6% growth in 28' ("Pup") trailers on rail points to the industry's ability to play in the ecommerce game
- 3. At least it doesn't appear that NAFTA will be eliminated although recent personal moves in the White House suggest trade hard-liners are once again on the ascendant. The rails have been lobbying furiously, as they should, but this is something they, and the North American economy, can't directly control
- 4. PTC will be the backbone of the coming digital railroad Several rails have reversed their public positions on PTC, set for installation completion by YE, from "unfunded mandate" to digital-enhancer (notably NS, CN and KCS). This is only symbolic, so far, but powerfully so. Perhaps winter can be avoided or embraced, after all....
- 5. Capex is nudging back up after a two year decline, and we expect increases on tech (hardware and opex-software) beyond PTC, and on capacity will coincide with improved returns, making the case for long term investment in the "renaissance"....

# Obituary for Albert J. Natick

Albert's career followed some interesting paths. As a young man, his family lived in Canada, where he qualified to teach students kindergarten -8th grade. During his days in the army, Albert rose to the rank of First Lieutenant Infantry Officer of the National Guard. In 1957 he entered the U.S. Air Force Reserve, later commanding an Installation Squadron. He retired in 1963 as a Captain. Albert launched his corporate career at the Chicago and Northwestern Railroad, where he met his wife, Lois. He was rapidly recruited to Libby, McNeil and Libby, holding the titles Assistant to the President and Director of Government Industry Relations. He loved to recount his experiences with President Nixon, Senator Dirksen and CIA officials. Albert continued his education via completion of an accelerated Harvard Management Program and coursework at Colgate and Stanford. An acquisition of Libby's led Albert back to the Chicago and Northwestern Railroad, where he retired as General Manager of Marketing and Sales. In retirement, he enjoyed many years traveling with his wife, time with family and a regular tee-time on the golf course. Private services were held.


