### Did You Know?... A Bit of Traffic Club History

Many of you might not be aware, but over its history the Traffic Club has had many notable individuals who have held membership at one time or another. You probably didn't know that Robert Todd Lincoln, son of President Abraham Lincoln was once a member. Mr. Lincoln was general counsel for the Pullman Palace Car Company during the famed Pullman Strike of 1894, and took over as president in 1897 upon the death of company founder George Pullman. The Club was only in existence for three years when Mr. Lincoln briefly held membership in the Traffic Club from 1910-1911. He resigned the following year upon his appointed to chairman of the board of the Pullman Company. The Club's historical files still maintain in its possession an autographed photograph of Mr. Lincoln.
